

2017 SUMMER CAMP

Please read the following information and submit the form attached by April 1st along with a \$100.00 non-refundable registration fee to guarantee a space for your child.

If there are any questions, please do not hesitate to call (410-766-0591) and someone will be happy to assist you.

CHILDREN ELIGIBLE: Children enrolled in St. Paul's School for the 2017-2018 school year will be given first priority. **AFTER April 1st,** designated openings are on a first-come-first-serve basis to children who are not enrolled in St. Paul's School.

HOURS: 7:00 AM to 6:00 PM. Parents arriving after the closing time of 6:00 PM, will be responsible for paying \$2.00 a minute for each minute after 6:00 PM. This policy is strictly enforced!

COST: We will have a MONTHLY RATE, a WEEKLY RATE and DROP-IN RATE. There is significant savings for you if you choose to pay by the month. The MONTHLY RATE must be paid by the 10th of May, June and July. We are offering electronic transfer through Vanco this summer. Please contact the camp office to get forms and fees. If the payment that is due is not made by the designated due dates, you will be charged a \$20.00 late fee after 10 days. The WEEKLY RATE IS \$185.00 and the DROP IN RATE is based on \$37.00 a day. Payment for each plan will work as follows:

*You are responsible for paying for the time that you reserve on your registration form.

- 1. **MONTHLY PLAN**
(THE MONTHLY PLAN AND VACATION DISCOUNT ONLY APPLY TO CHILDREN WHO ATTEND SUMMER CAMP ON A REGULAR WEEKLY BASIS JUNE THROUGH AUGUST)

***RATES ARE BASED ON WHAT GRADE YOUR CHILD WILL BE ENTERING FOR THE 2017 - 2018 SCHOOL YEAR.**

K – 8TH GRADE

\$471.00 DUE ON MAY 10thProvides care through June 30.

\$628.00 DUE ON JUNE 10th.....Provides care through August 4. **CLOSED July 3rd – 7th**

\$628.00 DUE ON JULY 10th.....Provides care through August 31.

- 2. **WEEKLY PLAN** is \$185.00 per week and is **due the 10th of May, June and July.**
(AVAILABLE FOR THOSE WHO ARE NOT ENROLLED FOR EVERY WEEK OF SUMMER)

3. FEE BREAKDOWN FOR THOSE CHILDREN WHO DON'T NEED CARE ON A REGULAR BASIS (USING CARE SPORADIC DAYS OR MONTHS):

*Checks returned for non - sufficient funds will be charged a fee of \$30.00. St. Paul's reserves the right to request cash payments for repeat offenders.

VACATIONS: Eligible families will receive a 50% reduction of their normal weekly fee for **TWO** weeks of vacation during the Summer Camp. **Vacation discounts will only be given to families using the Monthly Plan. IN ALL CASES, A MINIMUM OF 2 WEEKS ADVANCE NOTICE IN WRITING WILL BE NECESSARY OR YOU WILL BE CHARGED THE FULL AMOUNT. ALL VACATION CREDIT REQUESTS MUST BE IN THE CAMP OFFICE PRIOR TO JULY 10TH. NO VACATION DISCOUNTS WILL BE GIVEN AFTER JULY 10TH.** The maximum number of weeks allowed during any given year (Sept. 1 to Aug. 31) is 3 weeks of vacation time at a reduced rate.

MEALS AND SNACKS: Children should bring their lunch each day, except on specified days. Snacks will be provided unless a child has food allergies in which case the parents will be asked to provide the camp with snacks.

WORKSHOPS: Workshops are done on a first come first serve basis. To guarantee your child's spot in a workshop you need to have your registration and half of the Workshop payment to the Camp office by **Monday, May 15, 2017.** The second half of the Workshop payment is due **Friday, June 2, 2017.** No children will be accepted into the workshops after the due date, **Monday, May 15, 2017.** There are separate workshop sheets for the P's, K's, 1st/2nd and 3rd & up. **REFUNDS will ONLY be given for canceled workshops. NO EXCEPTIONS.**

INSURANCE: Student accident insurance is provided.

ATTENDANCE: St. Paul's Summer Camp is open Monday-Friday, beginning on June 12 and continuing until August 31, 2017. Camp will be CLOSED July 3rd – 7th. **PLEASE NOTE THE DAYS THAT SUMMER CAMP WILL NOT BE PROVIDED.**

WITHDRAWALS: Withdrawals from camp require a two week written notice. No changes or withdrawals will be accepted after July 10th.
